## NOMINATED AWARDS CRITERIA

## LEARNER OF THE YEAR

#### CRITERIA

For those in full or part-time study at Propertymark Qualifications centres or those distance learning studying towards, or having achieved, a qualification with Propertymark Qualifications:

- Strong dedication to the pursuit of their qualification or apprenticeship with Propertymark Qualifications
- Improved/benefited from their learning programme
- Application of their learning in their education/employment setting

The *Learner of the Year* award is given in recognition of an individual who has both embraced their learning programme with passion and shown commitment to applying their newly acquired skills in either continuing studies or in an employment context.

Nomination submitted via form and decided by judging panel against criteria.

### RISING STAR

#### CRITERIA

Learners who are new to the sector or have been in the industry for up to three years or less:

- Working towards or having achieved a qualification or apprenticeship with Propertymark Qualifications
- Positive attitude to learning and study
- Applying their learning to make a significant contribution to their team/employer

This award recognises learners making their mark in the property industry; those who have delivered tangible benefits to their employer—and are recognised as future leaders.

## EMPLOYER CHAMPION OF THE YEAR

#### CRITERIA

For corporate and/or independent employers, this award recognises:

- Employers supporting their employees in working towards and achieving a qualification with Propertymark Qualifications
- Employers making learning and development key to their success
- Employers supporting entry into the profession and encouraging and supporting professional development of their employees
- Outstanding steps taken by employers to involve their people, give them a voice in the
  organisation and develop an empowering culture, delivering tangible commercial and
  reputational benefits for the company

The *Employer Champion of the Year* is an individual or business who has worked to ensure the business and its employees have the skills and knowledge required to carry out and take forward their roles. As important as supporting the business and its individual employees, the *Employer Champion of the Year* promotes and celebrates learning and development and is also committed to their own continued professional development.

## WHAT THE JUDGES ARE LOOKING FOR

- Evidence of studies/achievement which has delivered real change/impact in the workplace/career development of the individual
   How achievement of the qualification, or studies towards a qualification, has supported a consumer-orientated approach to work and communication both with customers and colleagues alike
- Mentorship of other learners / colleagues
- A demonstrable commitment to learning and development
- A true desire to continually improve their knowledge and skills either in the workplace or place of study

**NOTE:** These criteria are for guidance only. You should feel free to interpret in a way you feel is relevant to your nomination. The key is to complete each of the fields as best you can to relate to your entry and not respond to the criteria exactly.

## CANDIDATES OF THE YEAR

These Awards are based upon achievement and performance of those who have achieved their qualifications and apprentice assessments with Propertymark Qualifications. They will be awarded by Propertymark Qualifications (awarding body) – based on examination results – for full qualification holders gained between January 2021 and December 2021. Awarding Body decision is final.

LETTING	Outstanding achievement on successful achievement of the full PMQ qualification in 2021 across Level 2/5 Award, Level 3/6 Award (and national equivalents) in Lettings, Inventory and Tenancy Deposit qualifications.
SALES	Outstanding achievement on successful achievement of the full PMQ qualification in 2021 across Level 2/5 Award, Level 3/6 Award (and national equivalents) across Residential Sales and Commercial Sales qualifications.
AUCTIONEERING	Outstanding achievement on successful achievement of the full PMQ qualification in 2021 across both Level 3 Awards, Chattels and Property.
LEVEL 4	Outstanding achievement on successful achievement of the full PMQ qualification in 2021 across both Level 4 Awards, Sales and Lettings
APPRENTICE	Outstanding achievement in their end point assessment for those having achieved the Junior Estate Agent Apprenticeship with PMQ up to and including end December 2021.
